### Colleague 7 Release Notes - 18.05.01

#### 1. Introduction

This document communicates the new features and changes in this release of Colleague 7.

#### 2. About This Release

Sprint Goal: To complete the Back Office project with the inclusion of Payment and Invoice Details held against the Placement record.

#### 3. New Features

#### 3.1 PBI 38049 - Colleague 7 - V6 Back Office Integration (Placement)

State: Done

Type: Enhancement

User Notes: BackOffice information against a Placement record is now stored in Colleague7.

As part of implementing this feature, there is a new User Group Permission in Colleague7 called "Placement - Back Office".

- When this is set to "No Access", then users will not be able to view/edit Invoice and Payment Details on a Placement.
- When set to "Full Access", then the Back Office Details can be accessed on a Placement record via the "Back Office" tab

When an Offer is Accepted, the Back Office details will be populated with the Payment Details from the Candidate and the Invoice Details from the Company. These fields can then be edited as they would on the Candidate and Company records.

These fields can also be made mandatory in the Mandatory Fields section of the Admin area.

When a Placement is advanced to Level 1 Authorisation, then all fields except the Back Office fields will be made read only.

When a Placement is advanced to Level 2 Authorisation, then if any Back Office fields are mandatory but empty then an alert will be displayed explaining that the Placement cannot be Authorised.

When a Placement is Level 2 Authorised, then the Back Office fields are also made read only.

User Notes: There is now a new Global and Personal Setting in the "Requirement" section labelled "Attach Default Document when sending CV or arranging Interview" which is a Yes/No option.

When this setting is set to "Yes", then when you select Candidates on a Requirement to send, then the default document of each Candidate will be automatically attached on the email.

#### 4. Bug Fixes

#### 4.1 PBI 42836 - Email Signatures not always being saved in Admin > User Maintenance

User Notes: User signatures now update correctly within the user maintenance area when editing and clicking between multiple users.

#### 4.2 PBI 43687 - Candidate Skill Grading Not Showing

Type: Bug

User Notes: A bug where the skill grading was not being shown has been fixed

#### 4.3 Default Country Allocation with Creating Record

State: Done

#### Type: Bug

User Notes: The candidate and company creation screens will no longer show the first country in the country lookup list when a default country is not defined.

When creating a candidate or company (without a default country defined) a blank option will be the default in the country list.

This is also the case when adding new secondary addresses to existing companies and contacts.
